“The mission of the South Carolina Emergency Response Commission (SERC) is to supervise and support the activities of the Local Emergency Planning Committees (LEPC) in each of the emergency planning districts or counties ensuring (1) that the plans in each district are adequately developed, maintained and exercised to facilitate an effective response to accidents and incidents involving hazardous materials and (2) to receive, process and report on chemical information received under the federal community right-to-know laws.”

SERC Activities

The reporting period for this update is July 1, 2019 to June 30, 2020. The SERC conducted two meetings this year: the first in June and the second in December. The SERC received briefings from representatives of several Federal and State Agencies as well as Local Emergency Planning Committees (LEPCs).

The SERC chairman and several other members visited several LEPC meetings throughout the year. The SERC members reported on their LEPC visits at the two SERC meetings. Their comments and observations are recorded in the SERC minutes distributed after each SERC meeting. Additionally, the South Carolina Emergency Management Division (SCEMD) distributes LEPC meeting schedule updates to members of the SERC. These schedule updates were included in the SERC Newsletters and are also available on the SCEMD website at <https://scemd.org/em-professionals/training/calendar/>.

South Carolina now has all 46 counties with active LEPCs with 100% participation across the state. The regional LEPC concept continues to provide a viable option for small counties; 17 counties participate in one of five regional LEPCs in the State.

The SERC newsletter continues to be provided to all LEPC chairpersons. During the past year, five newsletters were published and distributed with contributions from the Southeast Region Environmental Protection Agency (EPA), SCEMD, South Carolina Department of Health and Environmental Control (SCDHEC) and other sources.

This year, the SERC implemented a new format for the annual report using a standardized template through an online webpage. This report is the first annual report created using this process.

The State Emergency Response Commission (SERC) and the Local Emergency Planning Committees (LEPCs) continued to meet, share information and accomplish their missions this past year for the state and citizens of South Carolina. The challenges of the COVID-19 pandemic began in March 2020 and have caused deep impacts across the state. Community gatherings and government operations as well as the SERC and LEPCs have been affected. Guidance provided by the Centers for Disease Control (CDC) and SCDHEC have caused meetings to be postponed or canceled and significantly reduced the number of



attendees. Our LEPC community, to include the SERC, has addressed these challenges by embracing technology and conducting meetings via internet platforms such as WebEx, Zoom, Microsoft Teams and others. Despite these challenges, the various committees continued to meet; however, the number of LEPC meetings, exercises and other sponsored events was reduced from previous years. This SERC Annual Report reflects the impacts of COVID-19 on South Carolina, but it also shows the result of our community working to overcome these challenges and continue to function.

Despite the challenges and changes that have resulted from the national response to COVID-19, South Carolina LEPCs have reported positive results. The total number of members of LEPCs in all 46 counties was reported at 2,015 for 2020. There were a total of 28 exercises and 132 training events conducted, along with a total of 80 meetings held throughout the year.

DEPARTMENT OF HEALTH AND ENVIRONMENTAL CONTROL



After a process of reconsidering several parts of the 2017 Risk Management Plan (RMP) program amendments, the Environmental Protection Agency (EPA) published a final rule on December 19, 2019. Within the final reconsideration rule, the EPA rescinded portions of the 2017 amendments it deemed no longer reasonable or practicable. The EPA largely left unchanged portions of the RMP amendments rule relating to local emergency coordination, emergency response exercises, and public meetings.

Currently, the only major provision that has a compliance date is the requirement to periodically coordinate with local emergency responders and document engagement activities. The coordination activities must be conducted annually. Regulated facilities are required to maintain an up-to-date emergency response plan, updated emergency contact information, and any other information that is necessary for developing and implementing the local emergency response plan. The next major compliance date occurs on March 15, 2021, and requires regulated facilities to conduct public meetings within 90 days of any RMP reportable accident with offsite impacts. These meetings are required to provide information to the public about the accident including chemical release information, on-and off-site impacts, contributing factors, and operational or process changes that resulted from the incident investigation. Through 2026, future compliance provisions within the RMP reconsideration rule include developing an emergency response exercise program in coordination with local public emergency response officials and implementing the program to include periodic notification, tabletop, and field emergency response exercises.

Over the next few years, we expect these regulated facilities to be in contact with their local response officials to coordinate their plans, exercise programs, and possible public meetings to meet these new requirements. Abbeville County:

Abbeville County’s LEPC addresses all forms of hazards and not just hazardous materials. In addition, Abbeville County will conduct a full scale exercise involving local industry to reinforce the value of planning and preparedness.

The Anderson County LEPC meets every other month focusing on an all-hazards approach. Currently, the Tier II entities are on a fee schedule to help sustain hazmat response, training, and other basic costs of LEPC operation. Meetings are held at various locations around Anderson County to provide visibility of stakeholder operations and build strong planning and response capabilities.

Accomplishments

1. Established a new payment system for the Tier II fee collection, which includes online payment options with the ability to check payment status online.
2. Meetings are now held at local industries with tours to follow to allow for other companies to see what safety practices are put in place in other industries to potentially help others make safer decisions in their businesses.
3. Implemented web-based meetings to continue activities during the COVID-19 pandemic.
4. Updated the LEPC on plans for the O'Dell oil company fuel farm in Belton, SC.

Goals

1. Establish a mobile system for web-based and in-person meetings to allow for the options of others to join who cannot participate in person.
2. Establish an ad hoc committee to update the method of late fee collection and notification for those who may be late on payment.
3. Create an interactive environment for LEPC members to become more engaged in planning and preparation activities for potential hazardous material incidents or disasters.



Beaufort County

Despite limitations due to the COVID-19 response, the Beaufort County LEPC remained active throughout the past year with emphasis on hazmat team preparation and response capabilities. Longtime Hazmat Coordinator, Louise Murray, retired in June 2020. The LEPC focus for 2021 will continue to be on hazmat team readiness and interaction with local businesses to facilitate hazmat compliance.

Charleston County

The Charleston County Local Emergency Planning Committee (LEPC) was organized to fulfill the requirements of the federal regulations regarding Title III of the Superfund Amendment and Reauthorization Act (SARA) of 1986. The organization is composed of concerned citizens, representatives of industry, and emergency services. The LEPC seeks to formulate a partnership between its diverse members to prepare the County to withstand the effects of hazardous materials emergencies through planning and exercising the comprehensive emergency action plan.

The Charleston County EMD coordinates with the LEPC for hazardous materials planning and emergency response. EMD also coordinates the "Knox Box" program and receives Tier II Chemical Inventory Reports on behalf of the LEPC. Meetings are open to the public and held the second Wednesday of every other month.

1. The Boeing facility provided the setting for the May meeting. Those members in attendance were provided a tour of the facility, which highlighted its capabilities and resources.
2. Provided a workshop that included active participation by numerous business partners and governmental agencies. There has been increased interaction and collaboration between facilities that store hazardous materials and their local emergency responders.
3. Provided numerous hazmat training opportunities and equipment for classes to first responders, businesses, and members of the LEPC.

Goals

1. Continue to formulate a partnership between the diverse members of the LEPC to prepare the County to withstand the effects of hazardous materials emergencies through planning and exercising of a comprehensive emergency action plan.
2. Continue building response capabilities for major incidents, especially those related to hazmat.
3. Sponsor training classes and purchase training equipment for first responders. Focus on recruitment, more active participation and involvement by local industry and enhanced communications and coordination among LEPC partners to strengthen the role of the LEPC and encourage participation.
4. Sustain community outreach and continue to provide information and guidance on risk management planning to the numerous facilities within Charleston County.



Cherokee County

Cherokee County has an active LEPC that meets quarterly with approximately thirty-five (35) individuals. Highlights of the 2019-2020 include the re-election of LEPC Chairman, Vice-Chairman, and Secretary, Cherokee County Active Shooter Exercise, and the FEMA evaluation of their Catawba Reception Center/Congregate Care facility. Goals for the 2019-2020 year included increasing member participation, outreach to new companies, and increased member participation. This participation from local medical facilities, county first responder agencies, state agencies, and private enterprise ensure that the Cherokee County LEPC is an organization that undertakes a whole community approach to local emergency planning.

Chester County

The Chester County LEPC used the yearly HMEP grant to train area responders on responses to hazardous materials transportation incidents that pose a threat to the residents of Chester County. Chemical plants or facilities that use hazardous materials are selected as training sites for these exercises for two purposes: (1) provide responding agencies familiarity with facility layouts and potential hazards of the facility, and (2) provide responding agencies face-to-face contact with facility officials who will be their key contacts if called to respond to that location. Collaboration between exercise

planners and the facility is vital to produce a realistic exercise that provides the needed training to responders and plant personnel. These exercises also give the facility documented training that they use to fulfill their corporate safety program requirements. Their exercise cycle included FEMA evaluation of their Catawba Reception Center/Congregate Care facility plans.



It normally conducts quarterly meetings, and this year conducted meetings in August, November, and February before cancelling in-person meetings due to COVID-19. In May 2020, the LEPC conducted a virtual meeting where members discussed county COVID-19 protocols and PPE issues. The LEPC continued with virtual meetings during the rest of 2020.

Dorchester County

The Dorchester Local Emergency Planning Committee (LEPC) is appointed by the State Emergency Response Commission. The committee implements the Emergency Planning Community Right-to-Know Act (SARA Title III/EPCRA). The LEPC works with private businesses to identify and monitor existing chemical hazards within the County.

The mission of the LEPC is to:

- Develop and maintain a comprehensive emergency plan for the community
- Receive information about accidental chemical releases
- Annually update the information about chemicals stored or used by local facilities
- Collect, manage, and provide public access to information on hazardous chemicals in the area
- Support the local fire department and emergency response teams
- Educate the public about risks from accidental and routine releases of chemicals and work with facilities to minimize risks

Dorchester County LEPC continues to have increased participation and growth in membership since forming in 2010. The LEPC has built solid relationships with local industry, which has allowed meetings to be held on-site at partner facilities. Dorchester County LEPC continues to meet bi-monthly and produces a newsletter with a community spotlight to engage the community.

Accomplishments

1. Florence County LEPC, along with the Florence County Emergency Response Team (FCERT) and Windy Hill Volunteer Fire Company (WHVFC), funded, designed, and built a hazardous materials training platform that contains six different training props. This will allow the LEPC to conduct numerous scenarios as well as train new technicians.
2. Florence County Emergency Response Team conducted a Hazardous Materials Technician course for Windy Hill Volunteer Fire Company to better prepare for hazmat incidents within the county. Approximately 20 fire fighters participated in the training, which was provided over several months. The training culminated in an exercise conducted at Thermo Fisher Scientific. Refresher training will be conducted on a quarterly basis.
3. Florence County Emergency Response Team (FCERT) along with Windy Hill Volunteer Fire Company (WHVFC), conducted a hazmat response exercise with Thermo Fisher Scientific. Thermo Fisher's hazmat team members and WHVFC integrated with FCERT to conduct a three-hour drill in response to a simulated anhydrous ammonia leak.
4. Local industry donated supplies through the Florence County Emergency Management Division (FCEMD) to area hospitals and emergency responders to assist with the demands of the response to COVID-19. Supplies donated include N95 masks, N95 and P100 filters for half-face respirators and disinfectants.

Goals

1. The LEPC will train more fire departments on hazardous materials response.
2. The LEPC will conduct more exercises with industries that handle hazardous materials on site.

The mission of the Laurens County Local Emergency Planning Committee (LEPC) is to protect the community from harmful and possibly life-threatening effects of a hazardous materials release by developing and implementing policies and procedures for complying with the Emergency Planning and Right-to-Know Act (EPCRA), Title III of the Superfund Amendments and Reauthorization Act of 1986 (SARA Title III).

The LEPC consists of representatives from the following groups: elected officials, law enforcement, emergency management, fire service, emergency medical service, public health, hospitals, transportation, environmental organizations, community groups, facility owner/operators, and the media. The Executive Committee consists of the LPEC chairperson, LEPC coordinator, and the chairpersons for each subcommittee. The Executive Committee meets at the request of any member of the committee.

Laurens County has an active LEPC, which meets bi-monthly excluding the months of June and July. These meetings average approximately 50 attendees from county and city agencies, industries, schools, state agencies, and other organizations within the county. Laurens County incorporates an all-hazards approach to the LEPC meetings, which brings together a diverse group of individuals who share knowledge and information to enhance preparedness, response, and recovery. A broad range of topics are presented and discussed at each meeting, varying from mental health programs, industry information, weather updates, DHEC concerns, upcoming events within the county, and other topics helpful for planning purposes.




